## **INTRODUCTION**

#### **CONVENTION & PROTOCOL**

The International Registry of Interests in Rolling Stock (Rolling Stock Registry) operates within legal framework of the Cape Town Convention and the Luxembourg Rail Protocol. These documents create the foundation for the Registry:

- Cape Town Convention
- Luxembourg Protocol

State participation through the ratification of the Protocol is critical to the application and legal effect of registration of interests in the Registry. UNIDROIT, the International Institute for the Unification of Private Law, plays a key role in supporting the advancement of State ratification and maintains the complete listing of ratification to-date. *Learn more*.

#### REGISTRY

The Rolling Stock Registry offers customers the opportunity to register notices of their interests in railway rolling stock. The Registry's online search and registration services offer a secure real-time access point for financial interest in rolling stock.

The Registry operates a notice-based registration system. The Registry enables the search and registration of notices of interests in railway rolling stock. These notices provide awareness of a potential rights or interests in items of rolling stock. The Registry does not validate the rights or interests claimed as part of the Registration process.

To enhance the certainty of asset identification the Protocol introduces a new unique identifier for items of rolling stock – the URVIS identifier. The Rolling Stock Registry is the exclusive issuer of the URVIS Identifier.

The Model Rules issued under the auspices of the Working Party on Rail Transport of the United Nations Economic Commission for Europe outline the method and responsibilities in support of the operationalizing this new identifier. The Registry is governed by a Supervisory Authority and is operated under contract by Regulis S.A., a company headquartered in Luxembourg.

### **REGISTRY ACCESS**

- As a registry of a legal interests, security and integrity of processes are critically important including access to registry functions.
- The Registry offers two levels of user access Guest and Authenticated users.
  - o Guest users may conduct registry searches and request URVIS Identifiers.
  - In addition to the above, authorised users gain access to registration services as representatives of parties reflected on registration.

#### GUEST USER

#### **Guest User Registration**

• To become a Guest User and gain basic access to the Registry, select the 'Register' button from the Login page (*www.portal.rollingstockregistry.com*). The user registration form will be presented:

- Enter the first and last name as it appears on the government-issued identity document. Using the name as presented on the identity document is required if users intend to become an Authorised User and act in the capacity of an entity administrator.
- Add an email address where the user can be contacted for Registry matters. If interacting with the Registry for professional purposes, a business email address is preferred.
- Enter and confirm the password. A combination of eight to 16 letters, numbers and special characters are encouraged. The password must have at least one capital letter and one number.
- Select the country from the list provided.
  - Note: when countries of the European Union are selected, users will be presented with the option to enter a Value Added Tax (VAT) number. Professional users can enter the VAT number of their organisation.
- Review and agree to the Terms and Conditions by selecting the checkbox.
- When the above fields are complete, select the 'Register' button to complete the Guest User registration.
- A verification email will be sent to the email address provided. The email contains a link that must be followed before access to the Registry is provided.



• When verification is complete, enter the email address and password to sign into the Registry.

#### Multi-factor Authentication (MFA)

- For enhanced security of information and integrity in operations, the Registry utilises MFA.
- Guest Users must complete the MFA process to gain access to Registry Services.
- Upon the first login to the Registry, Guest Users will be presented with the following screen:

- Two MFA options are offered.
  - Authenticator Applications: third-party services that offer authentication services, typically via mobile device
  - o Email: MFA setup via email address
- Select the authentication method by clicking on the MFA image:
  - Users may change authentication methods on the *My Profile* screen once authenticated.
- When Guest User registration and MFA are established, users can access the Registry.
- At every sign in, the user will be required to enter their email address, password and complete the authentication activity.

#### Authenticator Applications

- The Registry is configured to work with any of the following authentication apps:
  - Microsoft Authenticator
  - Google Authenticator
  - Authenticator App
- To use an authenticator application, install one of the approved authenticator applications listed above, which are available from mobile device app stores.
- When the setup of the authenticator application is completed, log in to Registry and select the 'Auth App' icon from multi-factor authentication options provided.
- Scan barcode presented on screen using mobile device. Selecting the barcode will open the authenticator application. Follow the instructions presented in the application.
- The Registry site will present a set of recovery keys used in the case of lost mobile phone or other situations.
  - Save the keys using the 'Copy to Clipboard' function and save in a secure manner. Then select *Next*.



- $\circ$   $\;$  An authentication code is sent to the user's authenticator app.
- $\circ$   $\,$  On the Registry site, enter the six-digit code and click 'Complete Setup'.
- Multi-factor authentication is now complete, and the Registry login page will be opened.

#### **Email Authentication**

- To utilise an email account for authentication, select the *Email* icon.
- A code will be sent to the email address used for initial registration.
- Take the code from the email and enter it on the Registry site, then select the *Complete Setup* button.
- MFA using email is now complete, and the Registry login page will be opened.

#### DASHBOARD

• The Dashboard is the central location and starting point for all functions of the Registry.

- Navigate to registry functions using the menu on the left of the screen.
  - o Search: conduct informational searches and submit orders for Priority Search Certificates
  - *New Filing*: launches the menu to access all filings that may be submitted to the Registry.
  - *Consents*: Entity Administrators can access all in-progress consents for viewing status and completing consent submissions
  - *Messages*: access to all submission-related messaging, including submission summaries and transaction receipts
  - o Orders: access all Priority Search Certificates ordered through Search
  - Help: opens a window to the registry support materials
- Dashboard cards offer quick access to registry functions.
  - Cards are presented based on user access level.
    - Guest Users can quickly access URVIS Identifier and Search services and access the User Authorisation form.
    - Authorised Users and Administrators can access Search and URVIS Identifier services, registration and entity management services.
- See recent messages by selecting the bell icon on the top-right of the page.



• See *My Profile* and the *Logout* options in the top-right header.

#### **MY PROFILE**

- Select *My Profile* from the dropdown menu at the top-right of the page to review:
  - User Details: User ID, status, name and email information
  - User Principal Address (if applicable)
- User profile information is read-only. To make a change to user information, please contact the Registrar directly at the following email (registrar@rollingstockregistry.com).

#### **Password Updates**

- To update the user password, enter the password used to login in the Old Password field.
- Enter the New Password and then re-enter it in the Confirm Password field.
  - Any combination of eight to 16 letters, numbers and special characters are acceptable encouraged.
  - $\circ$   $\;$  The password must have at least one capital letter and one number.

#### **MFA Option Change**

- The user's selected method of MFA is highlighted here and can be revised by selecting one of the three available methods.
- When selecting a new authentication method, the user may be prompted to configure the method if it has not previously been used.
- To have changes take effect, select the *Save* button at the bottom of the page.
- A confirmation message will be displayed once saved.

#### INDIVIDUAL USER AUTHORISATION REQUEST

- To ensure the integrity of the Registry, an additional verification step must be completed to receive access to registration submission and consent services.
- Unlike Guest Users who are unable to undertake registration activities, active Authorised Users can:
  - Submit registrations
  - Consent to registrations
  - o Submit Entity Authorisation requests
- Authorised Users are granted 12-month authorisation, renewed annually thereafter, upon completion of the following process:

#### APPLY TO BECOME AN AUTHORISED USER

- To apply to become an Authorised User, select the *Apply for User Authorisation* button displayed on the User Authorisation card on the Dashboard, or find the *User Authorisation* option after selecting the *New Filing* button. The User Authorisation form will be presented:
- The user's first name and last name as provided in the Guest User registration are displayed.
- The following additional information about the individual is required:
  - o date of birth
  - o principal physical address
  - o telephone number

- Users have the option to include a Value Added Tax (VAT) number as part of their user profile. European Union (EU) users conducting transactions for professional purposes may enter their organisation's VAT number.
- Select *Next* to advance to the User Authorisation page.
- To verify the identity of the user, upload a scanned copy of a government issued identity document in PDF format.
- Select *Next* to review the details provided and complete the required declaration. Select *Submit* to be taken the Payment page.
- Authorised User access is granted on a paid annual renewal basis. Payment for the initial 12-month period is required.
  - Enter Credit card details and select Pay.
  - Upon completed payment, the form will be submitted to the Registrar for review.
    - The confirmation page identifies the Transaction Number and the Submission Reference number. The numbers refer to documents available in *My Filings*.
- The Registrar will review the submission and may require a brief interview to confirm user details. Registry staff will contact the user via email to schedule the interview.
- The Registrar may approve, return or reject the User Authorisation submission.
  - Users will be notified on the *Messages* tab when their application has been processed. The submission will be accessible in the *My Filings* area of the Registry application.
- In the event of a return, the Registrar may request clarification and/or additional information. The user can revise their application and resubmit.
- Upon approval by the Registrar, users will be granted 'active' status as an Authorised User. Authorised Users may act in the capacity of administrator for Authenticated Entities and are enabled to submit and consent to registry submissions.
- Personal information collected to complete the User Authorisation is treated in compliance with EU General Data Protection Regulation (GDPR).

#### AUTHENTICATED ENTITY REQUEST

• Like authorising individual users, the Registry also authenticates entity details and requires entities to be an active Authenticated Entity to:



- o be identified as a Named Party on Registrations

- To prepare an Authenticated Entity submission, select the *Create Entity* button on the card of the same name on the Dashboard.
  - Alternatively, select *New Filing* from the left-hand menu and then find the *Create Entity* filing and choose *Start*.
- The Entity Authentication form will be presented:

- Information regarding the entity to be authenticated is required:
  - *Entity name*: the legal name of the entity as identified on the corporate registration documentation from the entity's home jurisdiction.
  - *Email address*: the email address used for registry notifications related to the entity. It is recommended to include an email address that is accessible to individuals with accountability for the entity's dealings with the Registry.
  - *Entity physical address*: the address of the entity as it appears on the entity's corporate documentation (the state of the entity is a relevant consideration to the applicability of the Protocol).
  - *Telephone number*: should the Registrar seek clarification, the number provided should be of a person duly authorised to represent the entity seeking authentication.
- Information supplied should be reviewed in accordance with the *Convention*, *Protocol*, *Regulations* and *Procedures* and the anticipated interactions of the entity with the Registry.
- As part of the entity authentication process, legal details regarding the entity, and supporting documentation from the relevant government authority are required in the submission:
  - *Registered Entity Number:* Include the unique identifier for the entity as indicated on the official record from the agency with legislated authority for business registration in the home jurisdiction of the entity.
  - *Entity Type:* Include the business structure as identified on the supporting documentation.
  - *Upload Documentation:* Official documentation from the relevant government jurisdiction that confirms the entity details must be uploaded as part of the submission.



- Natural persons seeking to be identified for the purposes of being a Named Party or a Designated Representative will need to establish a separate Authenticated Entity, distinct from an individual's Authorised User credential.
  - In this scenario, enter the details of the natural person and enter the certificate number of the person's identity document and note the Entity Type as 'Natural Person'.
- When the Entity details are completed, select the *Next* button to advance to the Authority to Act as Administrator step.
- In preparing to submit an Authenticated Entity submission, the entity should identify an Authorised User to act as its initial administrator.
  - The entity's initial administrator is to submit the Authenticated Entity application.
- The Registrar requires evidence that the user has been duly authorised to act on behalf of the Entity as its initial administrator.
- An upload of a completed Authority to Act as Administrator form is required.
- Key information collected on this form:
  - *Name of Entity:* must match details included in submission and identified on legal documents.
  - *Details of the authorising natural person:* must be a director, officer or legal representative of the entity as recognised in the supplied documentation.
  - *Name of the Authorised User to be Primary Administrator:* must be the user submitting the Entity Authentication submission.
  - $\circ$   $\;$  Signature of the authorising natural person.
- With the Authority to Act as Administrator form uploaded, select *Next* to advance to the Review step.
- Review the submission details and complete the required declaration.
- Select the *Submit* button to advance.
- Authenticated Entity status is granted on a paid annual renewal basis, therefore payment for the initial 12month period is required.
  - Enter Credit card details and select Pay.
- All Entity Authentication submissions are subject to Registrar review. Upon completion of payment, the form will be submitted for review. The confirmation page identifies the Transaction Number and the Submission Reference number. The numbers refer to notifications available in the My Filings area.
- The Registrar may approve, return or reject the User Authorisation submissions.
  - Users will be notified on the *Messages* tab when their application has been processed. The submission will be accessible in the *My Filings* area of the Registry application.
- In the event of a return, the Registrar may request clarification and/or additional information. The user can revise their application and resubmit.
- Upon approval by the Registrar, an entity is granted 'active' status as an Authenticated Entity. Authenticated Entities may be identified as named parties on registrations, submit and consent to registry submissions and act in the capacity of Designated Representative.



#### MANAGE ENTITY ADMINISTRATORS

- For an Authorised User to submit and consent to submissions on behalf of an entity, they must be recognised as an administrator of the Named Party entity or Designated Representative of the entity.
- The initial administrator, as established through the initial entity authentication process, is responsible for managing the addition and removal of other administrators through the Manage Entity Administrators functionality.
- An entity may have multiple Authorised Users at any given time.
- To access the Manage Entity Administrators form, select *New Filing* from the left-hand menu. From the menu that appears select the *Manage an Entity* menu and choose the entity for which administrators are to be managed.

- The Manage Entity Administrators form will display all users currently with administrator credentials for the entity.
- To add a new administrator, select the Add Entity Administrators button.
  - Look up the intended Authorised User by their User ID number. This number must be provided to the initial administrator by the intended user.
  - Confirm the intended user information is returned and then select the *Save* button.
  - This process can be repeated as required to add multiple users.
- The Manage Entity Administrators form is also used to remove administrator access as required.
  - From the list of current administrators, select the waste basket icon of the intended user for removal.
  - Confirm removal by selecting Yes.
- Once all required changes to administrators have been prepared, select the Next button.
- Review the requested changes, complete the required declaration and then submit the changes to the Registry.
- Submission confirmation will then be displayed. Notifications regarding the submission are available in the Messages area and will be emailed. The submission summary can also be found in the *My Filings* area of the application.
- Once processed, any user identified as an Administrator may undertake preparing and consenting to submissions on behalf of the entity.



#### MANAGE DESIGNATED REPRESENTATIVES

- An authenticated entity may choose to authorise another entity to act on its behalf in registry matters. Typically, a named party (e.g. creditors or debtor parties) may delegate to a legal firm to undertake transactions on its behalf.
- An entity authorised to act on behalf of another is recognised as a Designated Representative in the Registry.
  - The Designated Representative relationship is between entities. Designated Representative status is not enabled at the individual user level.
- The initial administrator can add and remove designated representatives through the Manage Designated Representative functionality.
- Select the *Manage Designated Representatives* link from the Dashboard or the *New Filing* button on the left-hand menu. Under the Manage an Entity menu, select the target entity, then select *Manage Designated Representatives* from the menu.
- The Manage Designated Representatives form will display all entities with designated representative credentials for the Entity.

- Click the Add Designated Representative button.
  - Look up the target authenticated entity by their Entity ID number. This number must be provided to the Administrator by the target entity.
  - o Confirm the intended entity information is returned and then select the Save button.
- This process can be repeated as required.
- The Manage Designated Representatives form is also used to remove Designated Representative credentials as required.
  - $\circ$  Click the Waste Basket icon to select the entity for removal.
  - Confirm removal by selecting Yes.
  - Once all required changes to Designated Representatives have been prepared, click the Next button.
- Review the requested changes.
- Complete the required Declaration and then select the Submit button the changes to the Registry.
- Once submitted, the submission confirmation is displayed. The submission summary can also be found in the My Filings area of the application.



- Once granted designated representative status, administrators of the entity are enabled to act as administrators of the granting entity. This includes preparing submissions and consenting to registrations.
  - Primary Administrators are encouraged to review Designated Representative arrangements on a regular basis to ensure only intended entities are listed.

#### RENEWAL OF AUTHORISED USER STATUS

- To ensure the security and integrity of the Registry, only active Authorised Users may submit and consent to registrations.
- Active Authorised User status is granted for a 12-month period from the approval date of the Registrar.
- To submit a Renewal, the user must have been previously authorised by the Registrar.
- Personal information collected as part of the Authorised User Renewal is treated in compliance with GDPR.
- To prepare an authorised user renewal submission, select the *New Filing* option from the left-hand menu and then select the *Renewal Authorised User Status* option.
- The User Profile information will be presented for review.
- If the profile information is accurate, complete the required confirmation and declaration, then select *Submit*.
- Payment for the Renewal is required.
  - Enter Credit card details and VAT information (if applicable) and select Pay.
- Upon completed payment, the form will be submitted to the Registrar for processing.
- If the user profile requires changes, contact the Registrar via email at *registrar@rollingstockregistry.com* to request an update.
  - $\circ$   $\ \ \,$  Be sure to send the email from the account associated with the user profile.
  - $\circ$   $\;$  Include the User ID and the required change in the body of the email.
- Registry staff may review renewal submissions and may contact the user as part of the review.
- The Registrar may approve, return or reject User Authorisation Renewal submissions. Users will be notified via email.
- Upon approval by the Registrar, users will be granted 12-month active status as an Authorised User from the date of approval.

#### RENEWAL OF AUTHENTICATED ENTITY STATUS

- To ensure the integrity of the Registry, with limited exception, only active Authenticated Entities may be identified on submissions for registration.
- Active Authenticated Entity status is granted for a 12-month period from the approval date of the Registrar.
- An entity must have been previously authenticated by the Registrar to submit a Renewal.
  - The Renewal Authenticated Entity submission form is found in Manage an Entity area.
    - Select the *New Filing* option from the left-hand menu.
    - Select the *Manage an Entity* option that is presented at the top right of the menu.
    - A listing of all entities of which the user is an administrator will be displayed. Select the entity targeted for renewal.
    - Select the *Renewal Authenticated Entity Status* option.
- The Entity details as registered will be presented for review.
- If the profile is accurate, complete the required confirmation and declaration, then select Submit.
- Payment for the Renewal is required.
  - Enter Credit card details and VAT information (if applicable) and select Pay.
  - Upon completed payment, the form will be submitted to the Registrar for processing.
- If the entity profile requires changes, contact the Registrar via email at *registrar@rollingstockregistry.com* to request an update.
  - Be sure to send the email from the account associated with the entity profile.



- Include the entity name as registered and indicate the required change in the body of the email.
- Registry staff may contact the entity administrator during the review process.
- The Registrar may approve, return or reject the Entity Authentication Renewal submissions. The administrator will be notified via email.
- Upon approval by the Registrar, entities will be granted 12-month 'active' status as an Authenticated Entity from the date of approval.



## **URVIS IDENTIFIERS**

#### URVIS IDENTIFIER

#### INTRODUCTION

- The Luxembourg Rail Protocol introduces the Unique Rail Vehicle Identification System (URVIS) Identifier. The URVIS identifier is a unique number to be permanently affixed to an item of rolling stock.
- It is additional to, and not a replacement of, any existing identification systems as determined by applicable legislation or industry requirement.
- The URVIS identifier is the primary means of identifying an item of rolling stock in the operation of the Registry.
  - It is the required identifier for items of rolling stock for the purposes of registration.
  - $\circ$   $\;$  It is also the primary search criteria for the Priority Search Certificate.
- The Registry is the official issuer of URVIS identifiers. The Registry may enter into agreements with third parties to support the distribution of URVIS. Any such arrangement will see third parties distribute URVIS Identifiers as issued by the Registry.
- Identifiers are issued upon request, see the Request URVIS Identifiers section for order process information.

#### CHARACTERISTICS

- The URVIS Identifier is a 16-digit number.
- Each URVIS Identifier issued is a randomly generated number, where the first digit is a non-zero and the sixteenth digit is a calculated check-digit.

#### MODEL RULES

#### **OVERVIEW**

- The United Nations Economic Commission for Europe (UNECE) Inland Transport Committee adopted the Model Rules on Permanent Identification of Railway Rolling Stock ("Model Rules".) These rules outline the methods and responsibilities for affixing the URVIS Identifier to items of rolling stock.
- The complete Model Rules on Permanent Identification of Railway Rolling Stock document is available for download from the UNECE Working Party on Rail Transport Publications page:

- Parties intending to use the URVIS identifier must submit a declaration to the Registry formally adopting the Model Rules. The following section provides details on the process.

#### MODEL RULES DECLARATION

- Parties intending to make use of the URVIS identifier and be identified as a named party to registrations are required to first submit a declaration to the Registry formally undertaking to be bound by the Model Rules.
- A party seeking to submit such declaration to the Registry can do so by visiting the Get Started area of the Registry website at *www.rollingstockregistry.com/get-started* and then review Step 2 Submit a Declaration.


#### INTRODUCTION

- The Registry offers multiple submission templates to capture the required information to be registered. Generally, each registration or notice type has a corresponding form.
- Registrations are conducted in the following phases:
  - *Preparation*: Identify the intended registration or notice type and the input of all required data elements.
  - Consent: The consent of named parties is a requirement for registration. Named Parties or their Designated Representatives complete the consent process through the online application. Parties also have the option to refuse consent at their discretion should issues be found in the submission details.
  - *Payment*: Once the required parties have provided consent, the applicant returns to the submission and completes the necessary fee payment.
  - *Registration*: Upon successful payment, the submission is processed and registrations are generated. In most cases, the registration process occurs immediately upon payment completion.
    - Non-Consensual Right or Interest and Pre-Existing Right or Interest submissions are reviewed by the Registrar prior to registration.
  - *Notification*: The Registry utilises a combination of online messages and email notifications throughout the registration process.
- A single submission is utilised to create multiple registrations for each item of rolling stock identified in a submission. The information identified in the submission will be applied to each registration created.
  - For example, a single International Interest submission form with four URVIS Identifiers identified in the submission will generate four unique registrations one for each URVIS Identifier. Each registration will incorporate the details (i.e. creditor, debtor, lapse date, etc.) as supplied in the submission.
- Authorised Users can access the list of forms by selecting the *New Filing* button found on the main navigation menu on the left side of the screen. A list of submission types will be presented.
- Select the *Start* button beside the intended submission type to launch the submission form.
  - Only active Authorised Users may prepare submissions. See the Authorised User section for additional information.
- The following section provides specific information for each submission type.

#### INTERNATIONAL INTEREST AND PROSPECTIVE INTERNATIONAL INTEREST SUBMISSION

- To access the International Interest form, select the *New Filing* option from the left-hand menu.
- From the New Filing menu, select *Register an International Interest* or *Register a Prospective International Interest* options.
  - $\circ$   $\quad$  The following section applies to both submission types.





# **INTERNATIONAL INTEREST AND PROSPECTIVE INTERNATIONAL INTEREST SUBMISSIONS:** NAMED PARTY DETAILS

- The first step in preparing an International Interest submission is the identification of the Creditor(s).
- Authorised Users must be an Administrator of one of the entities to be identified on the submission or an Administrator of a Designated Representative for one of the entities. See the Administrator or Designated Representative sections for additional information.
- On the Creditor Details screen, select the Add new Creditor button.
- Enter the name of the entity to be added in the search field.
  - The application will offer options based on the information entered.
- To be identified as a Named Party to a registration, the entity must be registered as an active Authenticated Entity. See the Authenticated Entity section for additional information.
- Confirm the intended entity information is returned and then select the *Save* button.
  - If the intended entity is not returned, use the Authenticated Entity Search confirm the entity details and their status. See the Seach section for more information.
- This process can be repeated to add multiple entities as Creditors.
- To remove an entity, click the *Waste Basket* icon. Confirm the removal by selecting the 'Yes' button and the entity will be removed from the list.
- Select *Next* to move onto the Debtor Details step.

- Depending on the state of the debtor party, an Authorising Entry Point box may be presented.
- When presented, the user may enter the Authorising Entry Point code as secured from the Authorising Entry Point in the state of the debtor.
  - The Registry is not responsible for the issuance of these codes. Users will need to contact the state authority responsible for issuance of these codes.

    - o the changes to the particulars being sought
- The Registrar will review the request and follow up with the administrator to advise of required follow up actions to be undertaken. This may include the provision of additional evidence and authorisation materials.

- Consent of the creditor, or the creditor with sole right to discharge in the case of registrations with multiple creditors, is required to complete the Discharge submission.
- All required consents must be received before proceeding to payment and submission.
- See Consent Section for details.

## REGISTRATION OF DISCHARGE SUBMISSION: PAYMENT

- Once all required consents have been received, the applicant can complete payment and finalise the submission.
- Select the submission in the My Filings List and advance to the Pay screen.



- The system will calculate the required fees based on the submission type, the number of items of rolling stock being registered against and VAT (if applicable) calculations. The total due is displayed in the Filing Details area.
- Enter the payment details as required on screen. Select the Pay button.
- The payment details will be transmitted through a secure payment services provider.
- Any errors in processing the payment will be displayed.

## **REGISTRATION OF DISCHARGE SUBMISSION: SUBMISSION CONFIRMATION**

- Upon receipt of payment, the processing of the submission will be initiated. Many submissions are processed in real time.
- The confirmation screen provides important information for users:
  - Transaction (TR) number: used to identify the receipt for the submission in the My Filings area.
  - Submission Reference (SR) number: the unique identifier for the submission. This number is found in the My Filings area to access submission details. The SR number can also be used to prepare subsequent registration submissions and for searching the Registry.

# MANAGE CONSENT

# MANAGE CONSENT: OVERVIEW

- Consent of named parties is required to complete submissions and effect registrations. The determination
  of which named parties are to consent is dependent on the submission type and is identified in
  Regulations.
- The following users may consent to a submission on behalf of a Named Party:
  - Authorised Users identified as Administrators of the Named Party.
  - o Administrators of Designated Representatives authorised to act on behalf of the Named Party
- See the Managing Administrators and Managing Designated Representatives sections for additional information.
- Timeliness of registration is an important consideration. Upon initial submission, parties have 36 hours to complete the required consent submissions.
  - Should the necessary consents not be received within the 36-hour timeframe, the submission is returned to draft status and is available in the applicant's My Filings area.
- The Consents area of the Registry application is the central area to manage all consent activity. Select the *Consents* button on the left-hand navigation for access.

## MANAGE CONSENT: AWAITING CONSENT

• The Manage Consents screen provides a summary view of all submissions awaiting consent. This includes submissions made by the user as the applicant as well as submissions where the user is an Administrator for a party to the submission.

- A list of submissions currently in-progress for consent is displayed on the left. A search box is available to search the list by entity name.
- To view the status of submission consent by individual party, select the *Eye* icon. All parties to the submission will be listed by name. The respective consent status will be displayed to the right of the list.
- Where the user is authorised to act, a *Submit Consent* button is displayed next to the named party. Selecting this button will navigate the user to consent page for the submission.

#### MANAGE CONSENT: CONSENT

- The consent page presents a summary view of the submission. These details can be reviewed to ensure all information submitted is as expected.
- Near the bottom of the page the Consent box is displayed.
  - To consent to the submission, select the Yes, I agree option.
  - To refuse consent, select the *No*, *I am refusing* option. When this option is selected, a mandatory Reason field will be presented. Enter the reason for the refusal. This information will be shared with the applicant and other named parties.
- Select the *Next* button to proceed to the Review step.

## MANAGE CONSENT: REVIEW

- The Review page presents all information included in the submission. Users are encouraged to review all elements for accuracy. The *Previous* button allows a user to return to prior sections.
- Should the review require the user to conduct offline review activities, the Registry application offers the following options:
  - *Save Draft*: a draft of the submission will be saved and can be accessed from the My Filings section of the application.
  - *Preview*: Selecting the *Preview* button will generate a pdf file of the draft submission. The pdf file is downloadable for offline use.
- To finalise the submission, the user is required to confirm the Declarations as identified on screen.
- With the Declaration completed, the user can click the *Submit* button. The Registry application will review all information supplied. Should any elements require attention, warning messages will be displayed on the top right of the screen.
- Once all required consents are received, the initial applicant will be able to complete the Payment step and submit for registration.

# INFORMATIONAL SEARCH

- Informational searches are intended to support users in utilising the Registry. This includes searches to identify items of rolling stock for the purposes of conducting priority searches and information regarding the entities and parties interacting with the Registry.
- Informational search to support selection of Priority Search Certificates include:
  - Search by Running Number
  - Search by Submission Reference Number
  - o Self-search
- Results from the above informational searches will return information which includes the URVIS Identifier.
- Users will then have the option to select the URVIS Identifiers to order Priority Search Certificates.

## SEARCH BY RUNNING NUMBER

- To initiate a running number search, from the main Search page, select Running Number from the category list.
- Unlike URVIS identifiers, which have a standardised format, running number formats may vary and are collected on registration as entered without format restrictions.
- To return the broadest range of items of rolling stock in the informational search results, consider using the search tools provided and only including a subset of the running number in the search criteria.
  - *Exact match*: this option will return results only when there is an exact character-for-character match.
  - *Contains*: the application will return results where the characters identified in the search criteria are present.
  - *Starts With*: results will be returned where the first characters of a running number match the search criteria.
- Click the *Search* button to conduct the informational search.
- The Registry application will query the Registry to identify registrations where the search criteria match running number information. Users can anticipate the following nature of results to be returned in the Search Results area:
  - *Exact and Similar*: due to the varied nature of running number formats as well as the search tools and search criteria used, the results may return URVIS identifiers that include running numbers that vary from the search criteria.
  - Active and Inactive Registrations: the running number search will return results with URVIS identifiers for all registrations where the running number was identified at the time of submission



or amended. URVIS identifiers will be included in the result list regardless of the current status of the registration — active, discharged or lapsed.

- Data provided for running number informational search includes:
  - o Running Number: as supplied by the applicant on the registration
  - o URVIS Identifier: the identifier of the item of rolling stock
  - *No results found*: should the query return no matches to the search, a message indicating such will be displayed.

## SEARCH BY SUBMISSION REFERENCE NUMBER

- Submission Reference numbers are available in the submission summary documents.
- Click the Search button to conduct the informational search.
- The Registry application will query the Registry and prepare the list of URVIS identifiers that were identified in the submission. Users can anticipate the following nature of results to be returned in the Search Results area:
  - Active and Inactive Registrations: The submission reference search will return all URVIS identifiers identified in the submission regardless of any prior or subsequent registration activity involving the URVIS identifier, including discharged or lapsed registrations.
- Data provided for submission reference informational search includes:
  - o Submission Reference Number: as entered in the search field
  - URVIS Identifier: the identifier of the item of rolling stock
  - *No results found*: Should the query return no matches to the Submission Reference number entered, a message indicating such will be displayed.

  - *Exact match*: this option will return results only when there is an exact character-for-character match.
  - *Contains*: the application will return results where the characters identified in the search criteria are present.
  - *Starts With*: results will be returned where the first characters of a running number match the search criteria.
- Enter the name of the entity to be searched and the select the *Search* button to conduct the informational search.
- The Registry application will display the following information:
  - o Entity number
  - Entity name
  - o Email address
  - Entity physical address
  - Authenticated Entity Status (active or inactive)

#### SELF-SEARCH

- The entity Self-Search provides a means secure a listing of URVIS identifiers where a specific entity has been identified as a Named Party.
- To initiate a Self-Search request, the initial Administrator of the entity can contact the Registrar directly at *registrar@rollingstockregistry.com*. The administrator is to include:
  - o The particulars, including the Entity ID number, of the entity to be searched
  - The date range of registration activity to be included in the search results
- The Registrar will confirm the details of the request and arrange payment with the administrator.
- Once confirmed, the Registrar will compile the results and make them available to the administrator.

## PRIORITY SEARCH

#### SEARCH BY URVIS IDENTIFIER

- To initiate an URVIS Identifier search, from the main Search page, select URVIS Identifier from the category list.
- Once selected, enter the target URVIS Identifier into the search box. The number should be entered in full.
- Click the *Search* button.
- The Registry application will display the URVIS Identifier in the Search Results.
- Select the Add Certificate to Cart button for each Priority Search Certificate to be ordered.

- Select the *Download* icon to access the Priority Search Certificate.

# PRIORITY SEARCH CERTIFICATE

- A Priority Search Certificate is a comprehensive summary of registration activity for a specific item of rolling stock represented by the URVIS identifier.
- Certificates are generated at the time order and are a point-in-time history with the date and time of generation presented at the top of the certificate.
- Certificates are digitally signed at the time of generation. Digital signatures identify key information confirming the authenticity of the certificate and its contents. Users are may review the digital signature of Priority Search Certificates when viewing certificates.
- All registration activity is presented in chronological order as received by the International Registry.
- Summary information is supplied for each registration activity, including:
  - Registration type
  - o Registration number
  - o Party information including name and email address
  - Additional details (fractional or partial interest value, lapse date, right to discharge holder) when supplied or applicable.
- Unilateral registrations (R-NCRI, Pre-Existing Interests) will be identified with a 'Notice of Caution' flag upon receipt. The flag is removed for all registrations accepted by the Registrar.
